Caring like a State: Publicizing Family Caregiving Through Medicalization (under review at LAW AND SOCIAL INQUIRY)

Through qualitative analysis of fair hearing records from New York's Consumer-Directed Personal Care Program, this article examines how the medicalization of disability care provides a crucial yet limited mechanism that expands public responsibility and paid employment to the often-invisible labor of family caregiving.
