Dear ILR Alumni and Friends,

Tonight, we celebrate four ILR legacies, those of William Groat, Jerry Alpern, Pam Kimmet and Lisa Yang.

Through involvement with the school, such as service on the advisory board of the Center for Advanced Human Resource Studies, Pam shares her knowledge of HR best practices with ILR professors, practitioners and students.
